

Chapter 8

Biological Weapons and Drugs

ABSTRACT

Although some economists claim that healthcare is one of the public goods that can be privatized to create profits, it is, said Dr. Daigle, ten thousand times more corrupt than political corruption. For decades, you have been betrayed by those you elected because you celebrate and glorify them. After agreeing to the UN business meeting on the eugenics program, they have all agreed to terminate you at your expense. Your life depends on drugs and antidotes, or they terminate you by using drugs and technological means.

The greatest want in this world is the want of men. Men want to obtain what they cannot attain. Since becoming chancellor in 1933, Hitler grew to become obsessive with power. He wanted to obtain absolute power by synchronizing policies of organizations, businesses, political parties, and state governments to be in sync with those of Nazis. All then fell under Nazi leadership. Incrementally, economic, culture, and education policies are under the control of the Nazis. He became more obsessive and his nation to be above all other nations.

At the beginning of his era, the government, on the order of elected officials, had experimented with drugs for different reasons, including to control people and resources and even to achieve their individual ambitions.

Hitler was not only taking control of his country, but also very ambitious to control the world. He created a special army, the super-soldiers, the Wehrmacht soldiers, known also as the Nazi death machine. They were taught abstinence for good health.

How was Hitler able to create super-soldiers? He used drugs. Hitler himself authorized to use drugs on his soldiers so that they would become superhumans. The drugs were actually part of Hitler's plan to help pilots, sailors, and infantry troops to have superhuman performance. They were not allowed to have sex but were pumped with drugs and alcohol. The Nazis believed that drugging and intoxicating the troops could help the regime achieve victory over the Allies. Frontline troops were pumped with Previtin as they went to invade Poland and France. They were driven by speed, high on Previtin.

Said Von (2005), speed was the drug of choice, and many soldiers became addicted to morphine and alcohol. Although they were well supplied with the drug, they had to ask their family for more drugs because they had become addicted to the drug.

In his letter dated November 9, 1929, a young soldier wrote to his parents in Cologne asking for Previtin. Another 22-year-old soldier also wrote to his family in May 1940 asking for Previtin. This drug is a stimulant that gave them the speed they needed to be super soldiers. Hitler himself must have the

desire to be a superhuman so that he, too, with the help of his personal physician, experimented with the same drugs.

Although the Nazi campaigned against drugs radically because it was considered as a sign of personal weakness and a symbol of the country's moral decay, methamphetamine was adopted as a miracle drug that was commercialized in the late 1930s. Obsessed with physical and mental superiority, the Wehrmacht soldiers were pumped with methamphetamine, alcohol, and heroin with the argument that they provided hyper-alertness and vigilance. The Aryans, who were the embodiment of human perfection as the Nazi ideology, could now become superhuman. As superhumans, they could be turned into super soldiers.

Despite the "Reich Health Führer" and others warning about the risk of Previtin, the Nazi army was continuously prescribed with the drug while pilots and tank crews were supplied with methamphetamine tablets and chocolate bars loaded with methamphetamine known as *fliegerschokolade* or Flyer's chocolate and *Panzerschokolade* or tanker's chocolate. Andreas said that the Nazi armies, especially those on the front line, had taken various psychoactive substances, which were later largely used as synthetic performance enhancing drugs. The British press described the Nazi paratroopers as "heavily drugged, fearless and berserk."

Hitler was known as a dictator and ruthless because he consumed drugs, stimulants, and a mixture of drugs daily, from soft drugs to hard drugs. For example, he took methamphetamine, hormone injections, steroid injections, barbiturate injections, eukodal or a half-synthetic opiate, cocaine, amphetamines, and even cocktail drugs. Ohler (2016) described Hitler, in his book *Blitzed: Drugs in Nazi Germany* is a "blabbering junkie." His veins were damaged due to constant injections of opiate. He used propaganda to brainwash people to glorify, worship, and elect him. The propaganda he used was through his speeches, newspapers, radio and television, pamphlets, brochures, billboards, and anything that made people believe his words and follow his orders. They sacrificed their children to become the Nazi death machine, who later became addicted to drugs and died trying to make their leader's ambition a reality.

Hitler cast his dark shadow on his soldiers. He wanted to control the world under his arm with the help of his super-soldiers and the financial backing from the US. He prioritized his ego and ambition. With the political power he obtained, he became obsessed and wanted to control the whole world under his leadership. With his habit and physical condition, Ohler described him and his idea to be "extremely irrational" and "unrealistic."

Toward the end of the war, the Nazis even worked on a miracle drug for the troops. Vice Admiral Hellmuth Heye of the German port of Kiel, who later became a member of parliament with the Conservative Christian Democratic Party and head of the German parliament's defense committee, requested in March 1944 that they make a drug that can keep the soldiers ready for battle when asked to continue fighting beyond an abnormal condition and, at the same time, would boost their self-esteem. Then methamphetamine was considered the miracle drug for the troops. They were also given methamphetamine tablets, alcohol, and opiates. This drug was a key part of the Nazi military strategy.

Hitler declared, "We don't need weak people, we want only the strong!"

Therefore, the Nazis believed that weak people took drugs such as opium to escape, but strong people took methamphetamine to feel even stronger. This belief has then infected other fields, such as sport. Superego athletes take super-enhancing drugs before the competition to win. In the United States, prisoners are given drugs that they can be controlled, and then methamphetamines have been used by soldiers during intermittent wars worldwide, and its percentage of usage increased during the war in Ukraine.
